孫經先, Professor of Mathematics at Shandong **Sun** Jingxian University (山東大學) and Jiangsu Normal University (江蘇師範大 學), is an independent and experienced scholar in applied mathematics within the social sciences. He is completing a book about anomalous deaths during the Great Leap Forward, in which he carefully examines an established literature produced in part by such influential scholars as Ansley J. Coale and Judith Banister, as well as Jiang Zhenghua 蔣正華, Cao Shuji 曹樹基, Yang Jisheng 楊繼繩 and others. Based on extensive historical and archival research, including over 2,000 local chronicles and county chorographic records, he identifies a series of major errors in statistical compilation, computation, and analysis, and concludes that the previous consensus on a famine death toll of around 30 million is fundamentally flawed. His paper in this special issue forms a part of this research project, one that he has embarked on since 2010, and in which he proposes an innovative approach to explain discrepancies in the official demographic statistics for 1954-1982.
